- ❖ Courts 1 & 2 are the top (hard) courts on the far right (golf course end);
- ❖ Courts 3 & 4 are on the right hand side of the centre path;
- ❖ Courts 5 & 6 are on the left hand side of the centre path.

### Court allocations:

- ❖ Higher Seeds play on courts 1, 3 and 5 – and the score sheet should be kept in this shed;
- ❖ The lower seeds play on courts 2, 4 and 6.

### Important Information:

- ❖ If you have an 8:00am start please arrive by 7:45am to collect singles sticks, balls and have a short hit-up. Play your best of three (3) set singles first then one (1) set of doubles;
- ❖ Matches are to commence at 8:00am;
- ❖ If you have an 8:50am start, have a short hit-up then play your one (1) set of doubles first then your best of three (3) set singles;
- ❖ All games are LONG DEUCE;

## Wet Weather:

- ❖ The court secretary, Sandor will make the final decision regarding court playability;
- ❖ **Co-ordinators will communicate all WET WEATHER information via WhatsApp Team chat;**
- ❖ A decision CAN be made up until 10:00am to delay the start;
- ❖ Sandor may provide the alternative to play on the bottom synthetic grass courts instead of Courts 1 & 2.

## Team Availability:

- ❖ Players - please inform your TEAM and Co-ordinators via the Team's WhatsApp Group if you are unable to play for any reason. This needs to be notified at the earliest possible time so there is ample time to try to organise a reserve.

## Reserves:

- ❖ All players are to communicate via WhatsApp if they are unable to play for any reason;
- ❖ The Premier Co-ordinators will find a replacement;
- ❖ This could be from your team or from the reserve list.

## Responsibilities of the Team Captain/Manager:

- ❖ Ensure that your team members are available to play each Saturday by sending a WhatsApp message by around 7:00pm on Wednesday of each week;
- ❖ This message will include who the opposition is, which courts you are on, the start times for the seeds and who is rostered off;
- ❖ It is the responsibility of the Premier Co-ordinators to find a substitute/reserve player;

- ❖ Team Captain/Manager MUST obtain approval from the Co-ordinators regarding any substitute players;
- ❖ If RESERVES are playing, please notify your team members of their new start times to fit in with the reserve player;
- ❖ Submit a photo of the fully completed score sheet to your Team WhatsApp group (if you are still at the courts on completion of the day's play - if you need to leave before play finishes please allocate this duty to another team member).

## Responsibilities of each player:

- ❖ Each player is to submit their match score **via MatchCentre within 6 hours of completion of the match.** Preferably before leaving the courts so if assistance is required, it can be provided on the spot by a Co-ordinator. <https://matchcentre.tennis.com.au>. Sign in using your own unique player login & password then submit your singles & doubles score.

## DUTIES for each round:

### EARLY START PLAYERS:

- ❖ Collect single sticks, balls and score sheets from the Clubhouse.

### TEAM Captain or Manager:

- ❖ Check the pre-filled details on SCORE SHEET are correct, including team names (first mentioned team on the draw is the home team), players' names (including surnames), correct seed order for each player.

### LAST PLAYERS ON SITE - SCORE SHEET:

- ❖ If you are the last player on site for your team and your team Captain/Manager has left, the SCORE SHEET is your responsibility. Please complete in full, sign and post a photo to your WhatsApp Group.
- ❖ Return the singles sticks to the clubhouse and clean up any rubbish left at shelters.

### Responsibilities include:

1. Checking that all teams commence play at 8:00am;
2. Should a team be missing a player for any scheduled match, then:
  - a. Instruct the team to play another match, if other players are available;
  - b. If an eligible player or reserve is not able to commence the match by 15 minutes after the advertised start times (8:15am singles, 9:15am doubles, and 10:15am second singles) then the match shall be forfeited;
  - c. Make a decision regarding forfeit of the scheduled match, should a player not arrive by the end of the played match;
3. Maintaining a 'presence' around the courts;
4. **Providing support to players to assist with any issues during matches;**
5. Documenting any concerns/issues and forward to the Committee for review;
6. Remaining at the courts for the duration of the event;
7. Checking score sheets and MatchCentre are completed correctly.
